She currently serves as the Executive Treasurer of the organization. Soror Audrey has relentlessly addressed systemic racism and human rights violations against Black people, people of color, and those marginalized by life's circumstances. One of her goals is to disrupt racial disparities in the criminal justice system and achieve equality and equity within law enforcement. She worked with county officials and the NAACP to implement expungement clinics to help people with criminal records obtain Certificates of Rehabilitation, dismissal of convictions, and restoration of voting rights. Voting rights continues to be a top priority that requires our vigilance, advocacy, engagement, and protection.
